## Summary:

- Prepare and deliver promotional and information support materials on Project activities and achievements on video, audio and electronic supports;
- Develop and maintain the Project website, and other electronic supports, as to organise and populate both internal and external communication activities;
- Organise, develop and execute public relations events and ceremonies as per requirement from direct supervisor and/or from the Project Management Team;
- Act as the BEJV spokesperson, in coordination with the PR Team
  of the Employer, as required by the events and circumstances,
  and/or as requested by the PR, S&CR Manager and/or the Project
  Management Team;
- Provide information on environment, social, safety, sustainability
